Mayor Raye-Anne Briscoe called the meeting to order followed with the recitation of The Lord's Prayer.

Mayor Briscoe read Mayor Briscoe read three thank you notes. A thank you note from Renfrew Collegiate Institute for Brayden Wright, the co-op student who spent the fall term with us.
