A Report on Cannabis Retail Sales Outlets was reviewed by Council and upon consideration the following resolution was passed with a request for a recorded vote:

Resolution No 09/01/19

Moved by: Bob Hall, seconded by Kevin LeGris

Whereas municipal governments have a one-time opportunity to opt out of allowing retail cannabis stores in their communities;

And Whereas the AGCO is the provincial authority that licenses cannabis retail operators, authorizes cannabis retail locations and licenses senior store staff;

And Whereas the AGCO regulates and reviews all aspects of the retail operation including municipal and public input that the proposed store location is consistent with the public interest as defined in the regulations;

NOW THEREFORE BE IT RESOLVED that the Council of the Township of Admaston/Bromley enacts as follows:

- 1. That retail sales of recreational cannabis will be allowed in the Township of Admaston/Bromley;
- 2. That while there is no regulatory requirement for AGCO to act on municipal input, the Council of the Township of Admaston/Bromley has set out the three following principles which are to be considered by municipal staff when commenting to AGCO in response to notice of a specific proposed cannabis retail store:
 - a) The provincial licensing process does not remove the requirement to comply with the zoning by-law and other municipal planning documents. The definitions within the municipality's Official Plan and Zoning By-Law are applicable to all retail, including cannabis retail stores. Retail sale of cannabis from a provincially licensed store is legal and is a permitted use in the retail zones.
 - b) While the licensing of the store operation is the responsibility of the AGCO, the Building Code applies to cannabis retail store locations. Therefore, where a building permit is required, the building inspector will undertake duties as usual. Fire Code compliance is also mandatory.
 - c) In order to help ensure public health and safety, protect youth and reduce illegal sales, retail cannabis stores are discouraged where nearby properties are designed to serve youth including libraries, community centres or other sensitive facilities that serve youth or persons with mental health or addiction challenges.

A By-Law to adopt a Council Code of Conduct was presented for Council's consideration and the following resolution was passed:

Whereas Section 8 (9) of the Municipal Act, S.O. 2001, c. 25, as amended, provides a municipality has the capacity, rights, powers and privileges of a natural person; and

Whereas Section 11 of the Municipal Act, S.O. 2001, c.25, as amended, authorizes municipalities to pass by-laws regarding Accountability and Transparency of the municipality and its operations and of its local boards and committees their operations; and

Whereas Subsection 223.2 (1) of the Municipal Act S.O. 2001, c.25, as amended, authorizes municipalities to establish codes of conduct for members of the council of the municipality and of local boards and committees of the municipality; and

Whereas Subsection 223.3 (1) authorizes a municipality to appoint an Integrity Commissioner who would be responsible for performing in an independent manner the functions assigned by Council, Local Boards and Committees with regard to the application of a Code of Conduct; and

Whereas Subsection 223.4 (5) of the Municipal Act, S.O. 2001, c.25, as amended, authorizes penalties for a contravention of the code of conduct; and

Whereas on January 1, 2019 the Integrity Commissioner is responsible for the application of Sections 5, 5.1 and 5.2 of the Municipal Conflict of Interest Act, as amended to members of Council and of Local Boards and Committees about obligations under the code of conduct, procedures, rules, policies or the Municipal Conflict of Interest Act, as amended and the provision of education information to members of Council, Local Board and Committees of Council about the Municipal Conflict of Interest Act, as amended; and

Whereas the Code of Conduct sets minimum standards for the behaviour of Council Members, Local Boards and Committee and Committees of Council members in carrying out their functions and has been developed to assist all members to:

- 1. Understand the standards of conduct that are expected of them and the law that applies in relation to these standards;
- 2. Fulfill their duty to act honestly and exercise reasonable care and diligence;
- 3. Act in a way that enhances public confidence in local government;

NOW THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the Township of Admaston/Bromley adopts a By-Law to provide a Council Code of Conduct as an official policy document of the Corporation of the Township of Admaston/Bromley.

And FURTHER THAT the Council Code of Conduct shall apply to all Members of Council as well as certain Committees and Local Boards of Council including Standing Committees, Joint Committees, Ad Hoc Committees and Sub-Committees of the Corporation of the Township of Admaston/Bromley.
