Protective Services - Chair Mike Quilty, Committee Member Robert Dick

Council reviewed the minutes of Douglas Fire Committee meeting held January 9, 2019 and Fire Chiefs report dated February 13th, 2019.

Deputy Mayor Mike Quilty reported that the Police Services Board meeting is scheduled for next Tuesday at 6:30 pm.

Deputy Mayor Quilty further noted that the Emergency Management Training held in Horton yesterday was very informative and well attended by municipal Councils and staff from across Renfrew County.

Mayor Donohue expressed gratitude to the Office of the Fire Marshal and Emergency Management Ontario, the County of Renfrew and the Renfrew County District Health Unit for their contribution to the training session.

County of Renfrew - Mayor Michael Donohue

Mayor Donohue gave an update on the County of Renfrew Official Plan Amendment 25. He noted that the province is preparing a partial decision on OPA 25 and is working with the County to approve as much of OPA 25 as possible, text and mapping, and putting a pause on the contentious issues until after the PPS is updated, which is expected in the last quarter of 2019. It is expected that the partial decision to be made by March 24, 2019. The decision on these parts of the OP will be sheltered from appeal i.e., cannot be appealed. The County of Renfrew would be expected to submit a follow-up OPA, including public meetings etc, after the PPS is updated to address the remaining contentious sections and mapping matters.

Mayor Donohue stated that we hope the updated PPS will be less prescriptive on many of these contentious issues than the current 2014 PPS is and thereby result in a better outcome for the County. He further noted that the contentious sections and mapping in OPA 25 in which the Minister does not make a decision by March 24 will not come into effect, but will be open to appeal. Those contentious areas, for example the severance policies, will revert to the current 2003 OP until it is updated.
