## CORPORATION OF THE TOWNSHIP OF ADMASTON/BROMLEY

BY-LAW NO. 2015-11

Being a By-Law to authorize the execution of an agreement between the Township of Admaston/Bromley and the Town of Renfrew to allow access to the programs and facilities of the Renfrew Recreation Department

**WHEREAS** the Town of Renfrew has agreed to grant permission to the residents of the Township of Admaston/Bromley to use all the facilities of the Renfrew Recreation Department in the same manner and on the same conditions as residents of the Town of Renfrew.

WHEREAS the Township of Admaston/Bromley has agreed to pay to the Town of Renfrew, an annual fee to allow all Township residents to enjoy the same rights, privileges and access to the recreational facilities, programs and services as the residents of the Town of Renfrew.

**NOW THEREFORE** the Municipal Council of the Township of Admaston/Bromley enacts as follows:

- (1) That the Mayor and Clerk be, and they are hereby authorized to execute the agreement attached hereto and to affix thereto the Corporate Seal.
- (2) That the said agreement shall form part of this By-Law.
- (3) This agreement shall become effective January 1, 2015 and remain in force until December 31, 2019.

**READ** a first and second time this 5<sup>th</sup> day of February 2015.

**READ** a third time and passed this 5<sup>th</sup> day of February 2015.

## **AGREEMENT**

Made this 5 day of February , 2015

## BETWEEN

The Corporation of the Township of Admaston/Bromley

## AND

The Corporation of the Town of Renfrew

**WHEREAS** the Town of Renfrew is the owner of recreational parks and facilities located within the Town of Renfrew:

**AND WHEREAS** the Township of Admaston/Bromley wishes its residents to have access to the programs and facilities of the Town of Renfrew;

**AND WHEREAS** the Town of Renfrew is prepared to grant such permission to the residents of the Township Admaston/ Bromley;

THEREFORE the parties hereto agree as follows:

- Residents of the Township of Admaston/ Bromley shall be permitted to participate in activities and programs and to use all the facilities operated by the Town of Renfrew Parks and Recreation Department in the same manner and on the same conditions as residents of the Town of Renfrew.
- 2. At the end of each year the Town of Renfrew shall provide a summary of the town-run recreation programs and services, including the number of participants from the Township of Admaston/Bromley.
- 3. It is agreed that the Township of Admaston/Bromley will pay the Town of Renfrew the annual fee as provided for below to allow all Township residents to enjoy the same rights, privileges and access to the recreational facilities, programs and services as the residents of the Town of Renfrew. The Township shall pay to the Town for said services the following fees plus applicable taxes:

2015 \$21,000 2016 \$21,500 2017 \$22,000 2018 \$22,500 2019 \$23,000

The Town of Renfrew shall submit an invoice to the Township of Admaston/ Bromley in June of each year, with payment due upon receipt.

- 4. This agreement shall be for a period of Five (5) years commencing January 1, 2015.
- Either party may terminate this agreement at the end of each calendar year upon the giving of sixty (60) days notice in writing to the other party at its Municipal Office.
- 6. This agreement may be amended by the parties to the agreement, by mutual agreement at any time after commencement.
