4. Delegation – Landfill Expansion

Committee Chair welcomed the delegation to the meeting.

Bruce Leach provided a summary of the events to date. He also provided to Committee the issues that the property owners had with the two appraisals that were completed by the Township. The issues revolved around the value assigned to the property in question that the Township requires for the expansion of the Osceola Landfill. The property owners feel that other properties could have been considered instead that would have elevated the value of their property.

Committee asked if the property owners had ever received their own appraisal? They responded no, but may look at it in the future. The property owners noted that they were only using fair market values to determine the value of the property.

The property owners noted that there is an expired license for aggregate on the property in question.

The property owners believe their property should have a premium price associated with it due to its proximity to the landfill.

Committee asked if the sale of their property in 2013, which had a licensed pit on it, had a premium added to it? The property owners did not believe so.

The property owners would like to set up another meeting with staff to discuss the purchase of the property.
