#### **REPORT**

Re: Lynch Road Speed Concerns

#### **Background:**

As Committee is aware during the January 18<sup>th</sup> Council meeting a policy was adopted pertaining to Traffic Speeds on roadways. This Policy was using the Transportation Association of Canada's (TAC) automated spreadsheet to determine the recommended posted speed. Lynch Road's information was submitted into the system and furthering that a suggested speed of 70km/h was determined and adopted by Council. There came to be some later concerns that there was incorrect information entered into the Spreadsheet.

#### Discussion:

The County of Renfrew was very helpful in working along with and educating Township staff on how the system works as they are very educated with this system and have been using it for many years.

Being a new program to Township staff we reached out to the County once more to check all the information that was entered into the TAC Spreadsheet for Lynch Road. After reviewal by the County was brought to staff's attention there was a couple of small changes suggested to be made.

The previous total risk score for Lynch Road was 35 but after corrections were made the updated total risk score was lowered to 20. These changes were very minimal and had no impact on the suggested posted speed of 70km/h.
