Conference Update

- Well attended – OPP and Municipal
- Shared concerns on implementation challenges

- Association is strong voice with access to government.

Insurance

- Detachment Boards do not fall under the definition of “local board” as defined by the Municipal Act.
- No current product available
- Discussions with the ministry on this topic have been ongoing.
- OAPSB working with AMO.
- Looking at development of a new product specific to detachment boards accessible through local brokers
- Announcement expected in July.

Funding and budgeting

- OAPSB is working to secure implementation funding to carry Boards forward till January 25. There is a need to find interim funding to carry us forward, with the intent that back funding may be released by the Province. This remains very conceptual at this stage.
- Finance committee and TORs are the first step in the process.

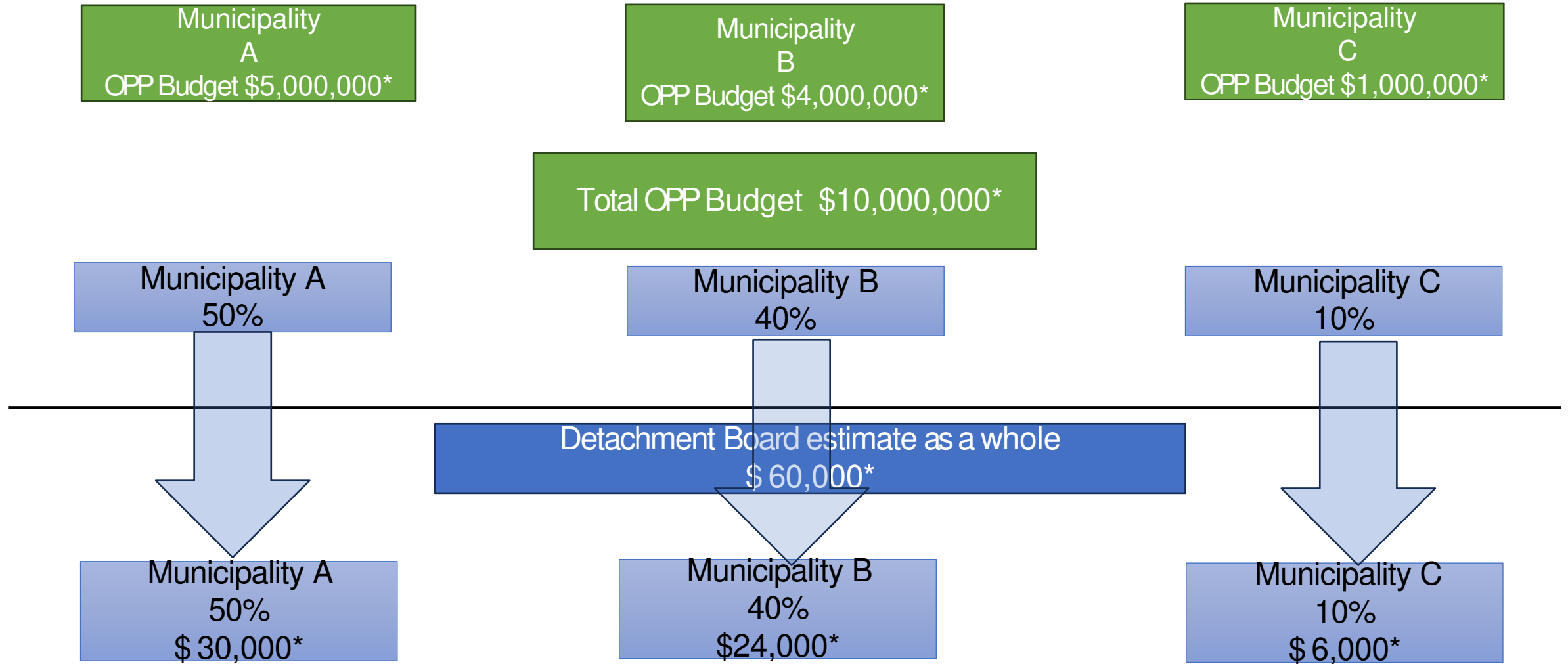
