AND WHEREAS should a municipality continue to provide services to the 'ineligible' sources, the municipality will be required to oversee the collection, transportation,

processing of the recycling, assuming 100% of the cost which amounts to yet another provincial municipal download;

NOW THEREFORE IT BE RESOLVED THAT the Municipality of Admaston/Bromley Council hereby request that the province amend Ontario Regulation 391/21:Blue Box so that producers are responsible for the end-of-life management of recycling product from all sources.

Background:

A Consent application has been submitted. The owners are proposing a lot addition to the abutting property located at 404 Pucker Street. The severed lands are 3.66 hectares in area with 292.5 metres of road frontage. The retained lands will be 121.41 hectares in area with 123 metres of road frontage.

The owners are proposing a lot addition application to enlarge the lands located at 404 Pucker Street. As a result of the lot addition, the lands to be enlarged will increase in area from 4.56 hectares to 8.22 hectares, and will increase in frontage from 69 metres to 361.5 metres along Pucker Street. The final retained lands will be 121.41 hectares in area with 123 metres of road frontage along Pucker Street.

The lot addition is considered desirable, as it will keep the local wetlands that travel through the properties on one lot, allowing for easier management and protection.

Section 14.3(14) of the Official Plan permits consents for lot additions, provided the resulting retained lot is not left undersized. In this situation, there are no planning issues with regards to lot size.

The severed and retained lands contain areas that are designated and zoned Environmental Protection. No development or site alteration is permitted in this area.

The only planning issue that needs to be addressed relates to the proper conveyance of the severed lands to ensure that they will legally merge with 404 Pucker Street which was previously severed by consent B268/93.

To allow the lots to properly merge on title, severance B268/93 will need to be cancelled. To do so, an application to cancel severance B268/93 must be submitted to

the County of Renfrew. This cancellation can be accomplished as a condition of approval for the proposed lot addition application.

A draft plan survey followed by a registered plan is a requirement. In addition, standard lot addition conditions will have to be met and a Certificate of Cancellation will have to be obtained.

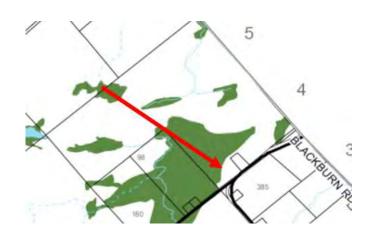

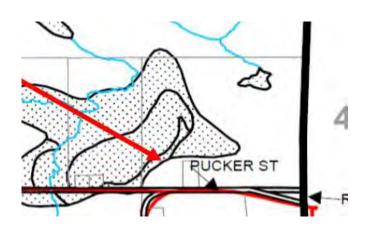

6. GENERAL PLANNING COMMENTS

The owners are proposing a lot addition application to enlarge the lands located at 404 Pucker Street. As a result of the lot addition, the lands to be enlarged will increase in area from 4.56 hectares to 8.22 hectares, and will increase in frontage from 69 metres to 361.5 metres along Pucker Street. The final retained lands will be 121.41 hectares in area with 123 metres of road frontage along Pucker Street.

Section 14.3(14) of the Official Plan permits consents for lot additions, provided the resulting retained lot is not left undersized. In this situation, there are no planning issues with regards to lot size.

Zoning By-law

The Township of Admaston/Bromley Zoning By-law requires a minimum lot frontage of 45 metres and lot size 4,047 square metres. As the proposed size and frontage of the enlarged lands complies with the local Zoning-By law provisions within the Rural (RU) Zone, there are no planning concerns.

Environmental Protection

The severed and retained lands contain areas that are designated and zoned Environmental Protection. No development or site alteration is permitted in this area.

Planning Act Requirements

The only planning issue that needs to be addressed relates to the proper conveyance of the severed lands to ensure that they will legally merge with 404 Pucker Street which was previously severed by consent B268/93.

Section 50(12) of the Planning Act provides that where a parcel of land is severed under Section 53, no further planning approval is required for subsequent conveyance of the identical parcel of land. The provision embodies the concept of "once a consent, always a consent." The problem is that a lot addition to a previously severed lot could be left on

its own as a standalone or orphaned parcel. In effect, the lot addition parcel would not merge on title to the severed lot it has been added to.

To allow the lots to properly merge on title, severance B268/93 will need to be cancelled. To do so, an application to cancel severance B268/93 must be submitted to the County of Renfrew. This cancellation can be accomplished as a condition of approval for the proposed lot addition application.

Re: Consent Application B31/25

Background:

A Consent application has been submitted. The owners are seeking to sever a 0.12-hectare parcel as part of a land swap with a neighbouring rural property, owned by Dave Donohue, Jordan Donohue and Joseph Connaughan. This application is being processed alongside File No. B32/25, which will add land to the subject property.

Lot addition B32/25 is being processed at the same time as this application and will affect the subject property and enlarged lands. If all lots are approved, the final size of the retained lands will be 33.52 hectares and the final size of the enlarged lands will be 19.47 hectares.

Currently, the lot being added to is landlocked, meaning it does not have direct access to a public road. The proposed lot addition will improve the situation by providing road frontage and access onto a municipal road (Mount St Patrick Road). This will not cause the retained parcel to be undersized, as it will still be more than 32 hectares in area and have 83.40 metres of road frontage. Therefore, this lot addition application is desirable.

A draft plan survey followed by a registered plan is a requirement. In addition, standard lot addition conditions will have to be met.

This application proposes to sever 0.12 hectares as part of a lot addition to a neighbouring property. The receiving property is described as Part of Lot 8, Concession 14, in the geographic Township of Admaston, and is owned by Dave Donohue, Jordan Donohue, and Joseph Connaughan. This application is part of a land swap with the lot being added to, and is being processed alongside consent File No. B32/25.

Currently, the lot being added to is landlocked, meaning it does not have direct access to a public road. The proposed lot addition will improve the situation by providing road frontage and access onto a municipal road (Mount St Patrick Road). This will not cause the retained parcel to be undersized, as it will still be more than 32 hectares in area and have 83.40 metres of road frontage. Therefore, this lot addition application is desirable.

It is expected that a driveway will be built on the severed lands in the future, as this is the only point where the property can connect to the road. As shown in the photo on the right, a local wetland designated Environmental Protection in the Official Plan is located just north of the severed parcel. 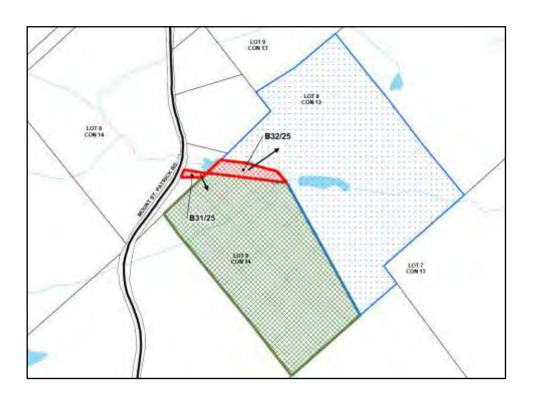

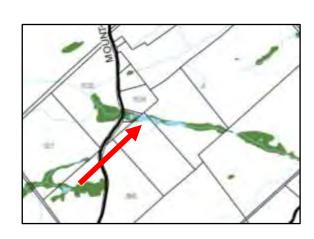

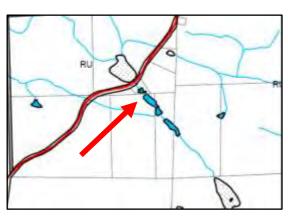

CORPORATION OF THE TOWNSHIP OF ADMASTON/BROMLEY

BY-LAW No. 2025-32

A BY-LAW TO CONFIRM PROCEEDINGS OF THE COUNCIL OF THE TOWNSHIP OF ADMASTON/BROMLEY AT THE COUNCIL MEETING HELD AUGUST 21st, 2025.

WHEREAS Subsection 5(1) of the Municipal Act, 2001, S.O. 2001, Chapter 25, as amended, provides that the powers of a municipal corporation are to be exercised by its Council;

AND WHEREAS Subsection 5(3) of the said Municipal Act provides that the powers of every Council are to be exercised by by-law;

AND WHEREAS it is deemed expedient and desirable that the proceedings of the Council of the Corporation of the Township of Admaston/Bromley at this meeting be confirmed and adopted by by-law;

THEREFORE the Council of the Township of Admaston/Bromley enacts as follows:

- 1. That the actions of the Council at its meeting held on the 7th day of August, 2025 and in respect of each motion, resolution and other action passed and taken by the Council at its said meetings, is, except where the prior approval of the Ontario Municipal Board or other body is required, hereby adopted, ratified and confirmed as if all such proceedings were expressly embodied in this by-law.
- 2. That the Head of Council and proper officers of the Corporation of the Township of Admaston/Bromley are hereby authorized and directed to do all things necessary to give effect to the said action or to obtain appropriate approvals where required, except where otherwise provided, and to affix the Corporate Seal of the Corporation of the Township of Admaston/Bromley to all such documents.
- 3. That this By-Law shall come into force and take effect upon the passing thereof.
