5. Transfer to Reserves – Year End Surplus Report

Treasurer-Deputy CAO/Clerk began her discussion about the year-end process and the completion of the 2024 financial statement. There was an operating surplus recognized by the auditors.

Discussion ensued as to how the operating surplus would be allocated between respective reserves as in keeping with the policies set out in the Reserve Policy adopted by Council in December 2024.

After much discussion, the mayor would rather not borrow money if it is not necessary, allocation of debt finance. Develop a resolution based on treasurer's appropriate recommendations to offset debt, direction is that a report be brought forward would be how allocations are figured out and on opportunities to reduce the township's debit financing. Treasurer-Deputy CAO/Clerk Coughlin did request if they were going to put it out to RFP, timing could be either late summer or early 2026 when the firms were not at their busiest.

Re: Recreation Agreement - Renfrew

Background:

The Township has had an agreement with the Town of Renfrew for over 20 years. The current agreement ended December 31, 2023. The Township has been paying for access to recreation services for 2024 and 2025 at the 2023 rate while the Town of Renfrew reviewed their agreements with neighbouring municipalities.

Our new agreement is attached for Committee review.

Discussion:

Below are the agreement costs since 2019.

The Town of Renfrew has confirmed that no capital costs are included in the new agreement and this includes debenture payments.

The Township's Douglas Recreation Committee has statistics on the attendees for their Beach Volleyball. (Attached).

Financial Implications:

Through the recreation agreement, residents of the Township of Admaston/Bromley are permitted the same rights, privileges and access to participate in recreation programs and services and to use recreation facilities operated by the Town of Renfrew Parks, Recreation and Facilities Department as the Town of Renfrew. In addition, by having this agreement in place residents would not have to pay a premium to register for programs / rent facilities.

The current agreement before Committee / Council for consideration includes an annual increase of 9%. This increase is related to changes within the recreation department from 2022 and 2024. Staff have received confirmation that the annual fee does not include special events or any capital costs.

As part of the agreement, the Town of Renfrew is required to provide the township with an annual summary of utilization.

The usage for Admaston/Bromley for 2024 was:

*Staff have confirmed that these figures do not include registration for hockey, ringette etc. as those enrolments are governed by each of their respective associations. 818 clients represents 27% of the Township population.

If this agreement is adopted by Council, this provision will be included in the 2026 budget and will result in .68% tax levy increase.

Alternatively, Committee / Council may consider not entering into this recreation agreement. This would result in residents having to pay 'out of town' user fees which are higher than residents of the Town of Renfrew, which may create financial hardship for some residents. If Council did not enter into a new agreement, this would result in 0.71% reduction in 2026 levy if all other things remained the same.

Shared Services Agreement for Recreation Services

THIS AGREEMENT dated this _	day of	, 2025
BETWEEN:		

The Corporation of the Town of Renfrew

(hereinafter called the "Town")

AND

The Corporation of the Township of Admaston/Bromley

(hereinafter called the "Township")

WHEREAS the Town of Renfrew and the Township of Admaston/Bromley are each municipal corporations established in the Province of Ontario, in the County of Renfrew;

AND WHEREAS the Town of Renfrew is the owner of various recreational facilities and the coordinator of a variety of recreational programs and services within the Town of Renfrew;

AND WHEREAS the Township of Admaston/Bromley wishes for its residents to have access to the recreational facilities, programs and services of the Town of Renfrew;

AND WHEREAS the Town of Renfrew is prepared to grant such permission to the residents of the Township of Admaston/Bromley on the conditions described in this agreement;

NOW THEREFORE, in consideration of the mutual covenants and agreements contained in the Agreement, and other good and valuable consideration, the parties hereto agree as follows:

Residents of the Township shall be permitted the same rights, privileges and
access to participate in recreational programs and services and to use
recreational facilities operated by the Town of Renfrew Parks, Recreation and
Facilities Department as residents of the Town; subject to the fees and premiums
identified in the Town's Fees and Charges By-law.

- 2. Using available reports through the Town's booking platform, the Town will provide a summary of recreation program and services usage by the neighbouring Township residents at the end of each calendar year.
- 3. It is agreed that the Township will pay the Town the annual fee as provided for below to allow all Township residents to enjoy the same rights, privileges and access to the recreational facilities, programs and services as the residents of the Town. The Township shall pay to the Town for said services the following fees, plus applicable taxes:

2026 \$30,3022027 \$33,0292028 \$36,0022029 \$39,2422030 \$42,774

The Town will invoice the Township in January each year, with payment due upon receipt.

- 4. **Term**: This Agreement shall be for a period of five (5) years commencing the 1st day of January 2026 and terminating on the 31st day of December 2030 (the "Original Term"). Should neither party provide the notice outlined in section 8 hereto, upon expiry of the Original Term, this Agreement shall be automatically renewed at a further 5-year term, under the same terms and conditions save and except section 3, which fees shall be increased by 9% per annum.
- 5. The yearly 9% increase was derived from the average operating budget percentage change within the recreation department from 2022 to 2024. This calculation does NOT include special events such as Renfrew Roots NOR any capital costs.
- 6. It is understood and agreed upon by both parties that the fees collected on an annual basis are for the current year's usage and financial commitment to the Town of Renfrew.
- 7. It is agreed that neither party will terminate this Agreement until December 31, 2030, and that should the Town or the Township not be interested in extending

- the agreement, six (6) months' notice prior to December 31, 2030, must be provided in writing to the other party at its Municipal Office.
- 8. This agreement may be amended by the parties to the agreement by mutual agreement in writing between both parties.
- 9. This agreement supersedes any previous shared services/non-resident user agreements between both parties.

Legal Considerations

- 10. Definitions: For the purposes of this Agreement, the following terms shall have the meanings set forth below:
 - a) "Residents" shall mean individuals residing within the geographical boundaries of the Township of Admaston/Bromley.
 - b) "Recreational Programs" shall mean organized activities and events coordinated by the Town of Renfrew Parks, Recreation and Facilities Department.
 - c) "Recreational Facilities" shall mean physical locations owned and operated by the Town of Renfrew for the purpose of providing recreational services.
- 11. Indemnity and Liability: Each party agrees to indemnify and hold harmless the other party from any claims, liabilities, damages, and expenses arising from the use of recreational facilities and participation in recreational programs by its residents. Each party shall therefore maintain general liability insurance coverage in an amount not less than \$5,000,000 per occurrence. Proof of insurance shall be provided upon request.
- 12. Force Majeure: Neither party shall be liable for any failure or delay in performance under this Agreement due to circumstances beyond its reasonable control, including but not limited to acts of God, natural disasters, pandemics, or governmental actions.
- 13. Governing Law: This Agreement shall be governed by and construed in accordance with the laws of the Province of Ontario.

BEING A BY-LAW TO AUTHORIZE THE EXECUTION OF AN AGREEMENT BETWEEN THE TOWNSHIP OF ADMASTON/BROMLEY AND THE TOWN OF RENFREW TO ALLOW ACCESS TO THE PROGRAMS AND FACILITIES OF THE RENFREW RECREATION DEPARTMENT

WHEREAS the Town of Renfrew has agreed to grant permission to the residents of the Township of Admaston/Bromley to use all the facilities of the Renfrew Recreation Department in the same manner and on the same conditions as residents of the Town of Renfrew.

WHEREAS the Township of Admaston/Bromley has agreed to pay to the Town of Renfrew, an annual fee to allow all Township residents to enjoy the same rights, privileges and access to the recreational facilities, programs and services as the residents of the Town of Renfrew.

NOW THEREFORE the Municipal Council of the Township of Admaston/Bromley enacts as follows:

- (1) That the Mayor and Clerk are hereby authorized to execute the agreement attached hereto and to affix thereto the Corporate Seal.
- (2) That the said agreement shall form part of this By-Law.
- (3) This agreement shall become effective January 1, 2019 and remain in force until December 31, 2023.

WHEREAS Section 391 of the Municipal Act, 2001, enables a municipality to pass by-laws imposing fees or charges on any class of persons; and

WHEREAS the Council of the Corporation of the Town of Renfrew is the owner of various recreational facilities and parks located within the municipality; and

WHEREAS the Township of Admaston/Bromley, Township of Horton, Township of Greater Madawaska and the Township of McNab/Braeside are desirous to enter into an agreement with the Town of Renfrew respecting the use of and access to recreation programs and facilities offered by the Town of Renfrew.

NOW THEREFORE the Council of the Corporation of the Town of Renfrew enacts the as follows:

- (1) THAT the Agreement attached hereto as Schedule "A" and made part of this By-Law shall constitute a contract between the Corporation of the Town of Renfrew and the Corporation of the Township of Admaston/Brornely.
- (2) THAT the Agreement attached hereto as Schedule "B" and made part of this By-Law shall constitute a contract between the Corporation of the Town of Renfrew and the Corporation of the Township of Horton.
- (3) THAT the Agreement attached hereto as Schedule "C" and made part of this By-Law shall constitute a contract between the Corporation of the Town of Renfrew and the Corporation of the Township of Greater Madawaska.
- (4) THAT the Agreement attached hereto as Schedule "D" and made part of this By-Law shall constitute a contract between the Corporation of the Town of Renfrew and the Corporation of the Township of McNab/Braeside.
- (5) The Mayor or Clerk are hereby empowered to do and execute all things, papers and documents necessary to the execution of this by-law.
- (6) This By-law shall come into force and take effect upon the passing thereof.

"Half Day" means up to 4 hours either between 8 am - 12 pm, 12 pm - 4pm, or after 4pm - 8pm (where available)

"Day" means a rental consisting of four or more hours, but less than 10 and approved by the Manager of Parks & Recreation or his/her designate.

"Event" means one (1) event pre-arranged and approved with the Manager of Parks & Recreation or their designate.

"Game" means, for the purposes of ball diamond rental, the time to play one (1) game, typically taking between 1-2 hours in length.

"Holiday Rate" means, any day defined by the Township or by the province as the recognized holiday including but not limited to: New Year Day, Family Day, Good Friday, Easter Monday, Victoria Day Canada Day, Civic Holiday, Labour Day, Thanksgiving Day, Remembrance Day, Christmas Day and Boxing Day. The Township reserves the right to select which arenas remain open during holidays.

"Hour" means, for the purposes of ice rental, 50 minutes of on-ice time. For all other services "Hour" shall mean 60 minutes.

"Market Rate" means the rate determined by the market (i.e. rate charged for a service at a particular time) rather than a calculated rate such as cost recovery.
